Possible questions:</p> <ul style="list-style-type: none"> <li>● Are ethics and morals the same thing?</li> <li>● What is the purpose of ethics and/or morals in healthcare?</li> <li>● What is an ethical dilemma? Have you ever faced one?</li> </ul> <p>Review <a href="#">Theme 2 Vocabulary</a> to review discussed terms and preview additional terms for upcoming activities.  <b>ELL support: Provide Theme 2 Vocabulary: Images while discussing terminology.</b></p> <p>Introduce ethical dilemmas by playing the <a href="#">Heinz Dilemma</a> video. Afterwards, have students work on the "<a href="#">Kohlberg's Heinz Dilemma</a>" in small groups. Students can answer questions orally and/or submit them in writing. Regroup as a class to review students' responses. Is there only one correct answer for each question?  <b>ELL support: Turn on subtitles/closed captions while playing the video.</b></p> <p>Alternate video option: <a href="#">Heinz Dilemma Version 2</a> (<i>slight story differences, subtitles unavailable</i>)</p>	<p>Group discussions (and/or written submission of answers)</p>

<p>2. Review medical ethics and codes of ethical conduct</p> <p><b>Target Standards</b>  <b>4.S.CC.2b</b> Analyze the purpose of information presented in diverse media and formats...</p> <p><b>4.R.CI.8</b> Compare and contrast one author's presentation of events with that of another (e.g., a memoir and a biography of the same person), including how they emphasize different evidence or advance different interpretations of the facts.</p> <p><b>3.R.CI.1b.</b> Determine two or more main ideas of a text and explain how they are supported by key details; summarize the main idea of a passage by answering who, what, when, why and how questions.</p>	<p>What is the origin of the principle "do no harm"?</p> <p>What ethical codes of conduct are healthcare workers obligated to follow?</p>	<p>Play Few Minutes Knowledge's "<a href="#">Hippocrates</a>" video to provide background on his life. Guide the class in reading the <a href="#">Original Hippocratic Oath</a>, including the author's note. Check students' understanding by discussing the author's note, particularly the third paragraph (key controversial aspects).</p> <p>Next, play AAH's "<a href="#">Hippocratic Oath</a>," which shows the modern version used today. Have students read the <a href="#">Modern Hippocratic Oath</a> aloud as a group, as if they were taking the oath.  <b>ELL support: Turn on subtitles/closed captions while playing all videos.</b></p> <p>Have students complete the <a href="#">Comparing Hippocratic Oath Versions</a> organizer, analyzing both versions of the oath and identifying specific changes in language and alterations in meaning.</p> <p>Play Columbia SPS' "<a href="#">Ethical Principles</a>" video to introduce the four basic pillars of medical ethics. Review the overview of the <a href="#">AMA Code of Medical Ethics</a> website. Have students read the <a href="#">list of specific chapters</a> and choose one to explore further. Have them select 1-2 opinions (articles) within that chapter and complete the "<a href="#">Gist Template</a>" for each one. <p>3. Identify common ethical dilemmas and determine appropriate responses</p> <p><b>Target Standards</b>  <b>4.R.CI.1</b> Determine a theme or central idea of a text and how it is conveyed through particular details and over the course of the text, including its relationship to supporting ideas; provide an objective summary of the text.</p> <p><b>4.W.TT.1</b> Write arguments to support claims with clear reasons and relevant evidence.</p> <p><b>4.W.WL.1c.</b> Support claim(s) with logical reasoning and relevant, accurate data and evidence that demonstrate an understanding of the topic or text, using credible sources.</p>	<p>How do healthcare workers cope with ethical dilemmas?</p> <p>Is there only one right way to handle an ethical dilemma?</p>	<p>Read Sermo’s <a href="#">“Identifying and Navigating Ethical Issues in Healthcare”</a> by dividing it into sections. Divide students into small groups and have each group focus on one section to complete a <a href="#">jigsaw reading</a>.</p> <p><b>ELL Support: The article is written at 10th grade level. Consider placing students into mixed-level groups so students can support each other with vocabulary / comprehension.</b></p> <p>Divide students into pairs or small groups. Give each group 1-2 ethical dilemmas from Nursing Process’ <a href="#">Common Ethical Dilemmas</a> article. Have students decide the appropriate response to each dilemma, submitting their answers in writing. Afterwards, share the <a href="#">answer key</a> and have students compare their responses to these answers. Lead students in a discussion, focusing on scenarios where their answers differed from the provided answer key.</p> <p>Extension activity: Provide additional dilemmas featured in <a href="#">Nursing Process’ original article</a> to continue discussion and/or research current events re: ethics in healthcare. <a href="#">ProCon.org</a> provides research on all sides of debatable issues; students can evaluate claims and supporting evidence for any topic in the “Health &amp; Medicine” category.</p>	<p><a href="#">Jigsaw reading</a> activity</p> <p>Submitted written responses for <a href="#">Common Ethical Dilemmas</a></p> <p>Extension activity research project</p>

This text is more advanced; encourage students to refer to their <a href="#">Theme 2 Vocabulary</a> as needed. Play HHS OCR’s <a href="#">“Your Health Information, Your Rights”</a> video to provide a summary of patients’ rights under HIPAA. Afterwards, have students review the accompanying <a href="#">Your Health, Your Rights Infographic</a>.</p> <p><b>ELL supports: Encourage students to reference their <a href="#">Theme 2 Vocabulary: Images</a>. Students can use the HHS site "<a href="#">Your Rights Under HIPAA</a>" as an additional source, including videos and general fact sheets.</p>

Clarify the definitions of multiple-meaning words using context: violation, penalty, civil, breach, etc. What do these words mean in different contexts?</p> <p>Play the "<a href="#">Spot the HIPAA Violations</a>" video. Have students write down each violation they see, trying to spot all four. Pause the video at 1:10 and have students share their answers, then resume the video to check responses for accuracy. Discuss: Were any of these violations on the <a href="#">Top 10 HIPAA Violations</a> infographic? What could the penalties be for each violation?  <b>ELL support: Turn on subtitles/closed captions while playing the video.</b></p> <p>Divide students into small groups to complete the "<a href="#">HIPAA Discussion Questions</a>" handout, using the <a href="#">HIPAA Compliance &amp; Violations Checklists</a> for additional reference, if needed. Play "<a href="#">What are the Patient's Bill of Rights</a>" (<i>subtitles are embedded</i>) to provide background on AHA's standards. Students can follow the partial transcript, <a href="#">The Patients' Bill of Rights</a>. As a class, read Navicent Health's "<a href="#">Patient Rights</a>."</p> <p>Discuss: Do these two sources convey the same information? How are they alike/different? Provide <a href="#">MyPatientRights.org</a> as an additional resource, created to help patients obtain information and resolve health plan barriers/issues.</p> <p>Divide students into small groups, with each group focusing on one special bill of rights: the <a href="#">Mental Healthcare Bill of Rights</a>, the <a href="#">Clinical Center Patient Bill of Rights</a>, and the <a href="#">Hospice Patient Bill of Rights</a>. Have each group present a summary of their bill of rights to the class, noting key distinctions from the primary versions.</p> <p>In 2003, AHA replaced the Patients' Bill of Rights with the Patient Care Partnership. <a href="#">This site</a> provides an overview. (Note: The <a href="#">“QuestionBuilder”</a> app is the same tool, but is only available on older devices.)</p> <p>Project/presentation: Ask students to imagine that they are teaching a friend, family member, coworker, etc., about the importance of being active participants in their own healthcare. What would this conversation look like? Have students explore AHRQ’s <a href="#">“Questions Are the Answer”</a> web page to select effective, persuasive materials (<a href="#">shareable resources</a>, <a href="#">patient PSAs</a>, <a href="#">doctor PSAs</a>, etc.). They can also use other appropriate lesson/theme materials. This project can be done individually or in groups, with a variety of presentation options. Students can write a sample dialogue, create a slideshow with dialogue/chat messages, perform a skit/ conversation for the class, record a video, etc.</p>
