

## Summary of CASAS Remote Testing Approaches for Illinois Title I and Title II Programs

<p><b>Approach #1</b></p> <p><b>1:1 Remote Control</b></p>	<p><b>Description:</b> One proctor, one test taker. Test taker takes the eTest through remote control of proctor’s computer screen via web conferencing platform.</p> <p><b>Proctor’s device - registered for eTest*</b></p> <ul style="list-style-type: none"> <li>➤ Desktop, laptop, or tablet computer running <b>Windows 10 or 11 PC</b> (no Chromebook) with all Windows Updates installed</li> <li>➤ Mac, if using the remote link to access the etest site, <a href="https://etestsonline.org/eTests2/remote/">https://etestsonline.org/eTests2/remote/</a></li> <li>➤ Webcam or attached video camera</li> <li>➤ Microphone and speakers</li> <li>➤ Internet access with bandwidth of at least 2 megabits per second (Mbps) download speed</li> <li>➤ Proctor’s device runs the web conferencing platform and the eTest software</li> </ul> <p><b>Test taker’s devices*</b></p> <ul style="list-style-type: none"> <li>➤ Windows laptop, desktop, or tablet computer</li> <li>➤ Mac desktop or laptop (no Chromebook)</li> <li>➤ iPad with 9.7 inch screen or larger, iOS 11 or higher</li> <li>➤ Webcam or attached video camera</li> <li>➤ Microphone and speakers, headphones NOT allowed</li> <li>➤ Internet access with bandwidth of at least 2 megabits per second (Mbps) download speed</li> <li>➤ Test taker’s device accesses the web conferencing platform</li> </ul> <p><b>Web conferencing platform</b></p> <ul style="list-style-type: none"> <li>➤ Any platform with screen sharing, unlimited time, and remote control</li> </ul>
<p><b>Approach #2</b></p> <p><b>1:1 or Multiple Test Takers</b></p> <p><b>Windows 10 or 11 PCs</b></p>	<p><b>Description:</b> One proctor with up to 15 test takers using breakout rooms via web conferencing platform. Test takers need a <b>Windows 10 or 11 PC</b> to access the eTest.</p> <p><b>Proctor’s devices*</b></p> <ul style="list-style-type: none"> <li>➤ Windows desktop, laptop, or tablet computer running Windows 10 or 11</li> <li>➤ Mac - if Apple Boot Camp is used to run <b>Windows 10 only</b></li> <li>➤ iPad, or Chromebook</li> <li>➤ Webcam or attached video camera</li> <li>➤ Microphone and speakers</li> </ul>

	<ul style="list-style-type: none"> <li>➤ Internet access with bandwidth of at least 2 megabits per second (Mbps) download speed</li> </ul> <p><b>Test taker’s devices - registered for eTest*</b></p> <ul style="list-style-type: none"> <li>➤ <b>Windows 10 or 11</b> laptop, desktop, or tablet computer</li> <li>➤ <u>Not</u> supported: Mac, iPad, and Chromebook</li> <li>➤ Webcam or attached video camera</li> <li>➤ Microphone and speakers</li> <li>➤ Internet access with bandwidth of at least 2 megabits per second (Mbps) download speed</li> <li>➤ Test Takers take the eTest on their device</li> </ul> <p><b>Web conferencing platform</b></p> <ul style="list-style-type: none"> <li>➤ Any platform with screen sharing, unlimited time, plus breakout rooms if more than 1 test taker</li> </ul>
<p><b>Approach #3</b></p> <p><b>1:1 or Multiple Test Takers with Chromebooks and iPads</b></p>	<p><b>Description:</b> One proctor with up to 5 test takers using Chromebooks or iPads. This approach requires <u>two</u> devices for the test taker: a Chromebook or iPad to take the test and another device i.e. smartphone, for the proctor to monitor the test.</p> <p><b>Proctor’s devices*</b></p> <ul style="list-style-type: none"> <li>➤ Windows 10 or 11 desktop, laptop, or tablet computer</li> <li>➤ Mac, iPad, Chromebook</li> <li>➤ Webcam or attached video camera</li> <li>➤ Microphone and speakers</li> <li>➤ Internet access with bandwidth of at least 2 megabits per second (Mbps) download speed</li> </ul> <p><b>Test taker’s devices - test takers need <u>two</u> devices*</b></p> <ul style="list-style-type: none"> <li>➤ Chromebook using Kiosk Mode (registered for eTest)</li> <li>➤ iPad using Guided Access Mode (registered for eTest)</li> <li>➤ Webcam or attached video camera</li> <li>➤ Microphone and speakers</li> <li>➤ Internet access with bandwidth of at least 2 megabits per second (Mbps) download speed on Chromebook or iPad</li> <li>➤ Test takers must use a smartphone or second device (not the same device for testing) as an external camera so the proctor can monitor the test</li> </ul> <p><b>Web Conferencing Platform</b></p> <ul style="list-style-type: none"> <li>➤ Any platform with unlimited time and breakout rooms if more than 1 test-taker</li> </ul>
<p><b>Approach #4</b></p> <p><b>1:1 Oral Responses</b></p>	<p><b>ICCB has not approved this approach for use in Illinois programs.</b></p>
